

Colorado City Metropolitan District PUBLIC NOTICE BOARD OF DIRECTORS STUDY SESSION

A study session for the Board of Directors of the Colorado City Metropolitan District will be held Tuesday, April 30, 2024, beginning at 6:00 p.m.

1. Paychex's

Training was held on Friday, April 26 for staff to get phone apps and information about logging on, posting, etc. We hope to start CCMD the pay period of May 18 with new the payroll program. CCMD will still have staff complete paper time sheets as backup.

Letter to Authorize users for Colorado City Metro

Required formal letter for removal of past financial director, and to add both District Manager and Accounts Payable staff on the account, so we have two deep.

2. Stewart Ranch Update

Gary McCormick came in last week to discuss this change, as he is on the water line too & will need a meter & to pay for water usage.

No answer from Deanna at Stewart Ranch. Mr. Eccher, Mr. Gross, Mr. McCormick, Deanna Jordan & another board members will need to hammer out a plan.

Bid from Joel for valve – some need replacement anyway, we can change where we install the valves in the line.

Need to set up meeting now, so no delay tactic on this moving forward per our timeline. Action Item: Set date for shut-off!

Road Servicing: Owner asking about getting a road serviced. If they are only getting lot lines vacated, we are not required to service. If they are building, they can pay to have it expedited \$2500 for first section, then \$1500 for each additional section. CCMD has no record of who to maintain this street, so it will fall to us.

Otherwise, it is approximately 18 months out after building completion, depending on CCMD budget/planning.

3. Ford 1997 to sell – not applicable, the buyer backed out of the sale (no door handles, transmission/engine not running & other things wrong)

Suggested we post on FB for minimum of \$500 prior to selling as scrap. Don't want it to sit around becoming junk in one of our lots.

4. GMS pay request.

ARPA to finish tanks – last tank. Working to figure out our system. Greg, Gary, Ayden & Jim met with them last Thursday. Next meeting on May 14th with Jason Myers.

The new bill is for 11 hours (2 different engineers). They are currently 30K over submitted proposal.

Working to finish tanks #1 & #2 now.

Will need additional funds (grant) for money to do work on tank #3. Inside will require sand blasting due to rust at seams.

5. CCAAC Reviews

Bob Smith to get a copy of the regulation regarding vehicles on property, are they required to be currently licensed. How many allowed on property if unlicensed?

Complaint regarding the foundation of a property on Waco Mish/Red Cloud (ie no skirting) house is still under construction.

Another complaint re a Conex box property at Kaneache/Satanta Blvd, with no house/trailer & junk.

Complaint about color of a new build – house is blue (there are 3 other blue houses in area)

New complaint about RV & people in tents – need to obtain more information.

6. READING BY CHAIRPERSON OF THE STATEMENT OF CONDUCT AND DEMEANOR.

7. CITIZENS INPUT

Bob Smith – General maintenance of the irrigation ditch on 165 (water supply ditch) trees are caving in sides. This will be included in the dam project, but additional grants will be needed to help cover the funding of repairs. District Manager would like to have the irrigation ditch covered also.

He also stated Colo City homeowners would have more pride in the area if general maintenance upkeep were done regularly. i.e.: mowing/weed removal of CCMD green space along 165. Mr. Smith has been mowing for the past 5 years (400 hours of time, and funding from his own pocket 20K). CCMD will check with County State Highway to help with the moving along 165. Mr. Smith states need to keep on top of the gourd weeds as they will take over if left untouched.

Thanks, BOB, for all the work on mowing & weed control, you are appreciated!

Josh could have the school kids help, but only available now on Fri/Sat.
